## 8 小结

在心力衰竭患者利尿药的应用中,如何根据临床试验证据和临床经验,合理的选择利尿药的剂型、剂量、使用方法,避免利尿药的不良作用,达到临床最大获益,是临床医生需要考虑的细节问题。细节决定成败,让我们把利尿药用得更好、更合理、更规范。
